CMS's Memorandum Summary for Erroneous Schizophrenia Coding

- CMS memo <u>QSO-23-05</u>: Adjusting Quality Measure Ratings Based on Erroneous Schizophrenia Coding and Posting Citations Under Dispute
- How does the *Pre-Admission Screening and Resident Review* (PASRR) relate to the *Quality, Safety and Oversight* (QSO) memo and what are the implications of an inaccurate PASRR?
- How does a lack of supporting documentation and inaccurate Minimum Data Set (MDS) coding put your facility at risk for possible deficiencies and citations?





PASRR Best Practices

- Ensure your facility has an up-to-date *Pre-Admission Screening* and *Resident Review* (PASRR) that accurately reflects the resident's current presentation
- Questions to consider when reviewing the PASRR may include:
 - Is an updated psychiatric evaluation needed for diagnosis clarification?
 - Are you auditing the resident's diagnosis list, clinical and psychiatric/psychology documents and antipsychotic use?
 - What are next steps when my facility receives a Level II PASRR Evaluation?
 - How often is the resident's PASRR reviewed? Who reviews it?
 - Does your Minimum Data Set (MDS) Coordinator collaborate with Social Services or PASRR designee to review psychiatric census?





Practices to Reduce Inappropriate Antipsychotic Medication Use

- Implement a monthly *Psychopharmacology* (PsychPharm) and *Gradual Dose Reduction* (GDR) Review Meeting
- Develop a plan for reducing antipsychotic medication and incorporate initiatives into monthly PsychPharm Meeting
- Verify if there is evidence of Dementia, Alzheimer's Disease, Neurocognitive Disorder, Traumatic Brain Injury or *Intellectual Disability/Development Disability* (ID/DD)
- If a cognitive decline is identified, create a process to clarify if Dementia is the primary diagnosis



Trauma Informed Care and Non-pharmacological Interventions

- What is Trauma Informed Care (TIC)?
- Designing a plan to implement individualized and nonpharmacological interventions, care plans and behavior monitoring
- Examples of individualized interventions:
 - Substance Use Disorder (SUD) services
 - Mental health services that include psychiatry and psychology or counseling
 - Therapeutic groups tailored to your resident population
 - Life enrichment activities that meet your residents' needs and interests
 - Non-pharm and individualized interventions based on a resident's preferences, needs, strengths and abilities that incorporate positive reinforcement





Quality Assurance and Performance Improvement (QAPI)



- If a deficiency is identified, initiate a Performance Improvement Plan (PIP) to address PASRR and psychotropic diagnosis
- Telligen offers 1:1 technical assistance to support facilities in QAPI initiatives, including reducing inappropriate antipsychotic medication use


