IMPROVING DIABETES CARE TOGETHER BUILDING A HEALTHIER FUTURE IN IOWA

Diabetes mellitus is a significant problem in the U.S., and in lowa 9.3% of the adult population have an official diagnosis, with an additional 70,000 lowa adults living with diabetes who don't know it. Diabetes-related costs in lowa are estimated at \$2.6 billion dollars, and those with diabetes can experience many negative health effects and complications including heart attack, stroke, kidney failure, vision loss, amputations and a shortened life expectancy.¹ Telligen works in lowa to improve diabetes care through evidence-based interventions and providing one-on-one enhanced technical assistance, including training and support, on-site and virtual observational assessments, data analysis, coalition building and assistance with addressing the social determinants of health.

Nearly 1 in 5 adults in lowa ages 65+ have been diagnosed with diabetes²

Since January 2023, Telligen has provided enhanced technical assistance (TA) to an organization within an Accountable Care Organization (ACO) on their Quality Payment Program (QPP) diabetes measure. This is one of nine organizations within the ACO, of which Telligen is assisting their five lower-performing hospitals.




